Portonovo is an attractive, recently completed (2017) complex with a small number of townhouses built around a communal swimming pool and features attractive terraces and garden areas. It is located in the centre of Los Cristianos, close to the popular Passarella Centre and about ten minutes' walk to the beach and the port, and all of the amenities Los Cristianos has to offer.

This beautifully presented air conditioned townhouse is spacious and distributed over three floors with fantastic outside space to enjoy the all year round sunshine and is offered for sale inclusive of the high quality featured furniture. On the ground floor there is an independent fully fitted and equipped kitchen with seating area and access through French doors to the breakfast terrace boasting morning sun.
