Torviscas Alto is ideally located for those who want to be close to but not in the middle of the busy tourist areas and yet remain within easy reach of all the main amenities and coastal areas. This property is located just over the motorway from the main tourist zone yet still in a low-lying area so reaching it on foot is not a problem. Locally, there are a number of local bars and restaurants, a supermarket and the renowned Aqua Club Termal with its expansive spa and sport facilities. Also nearby is the X-Sur (formerly Gran Sur) shopping mall with its shops, restaurants and multiscreen cinema. Las Mimosas is a delightful complex which has been recently enhanced by the upgrading of the swimming pool and renovation of the communal terraces. The pool is heated during the slightly cooler winter months for year round enjoyment and from the pool area, you can enjoy beautiful panoramic sea views.

This superb property is in lovely condition both internally and externally and is well decorated and furnished throughout. At entrance level you can find a full shower room, an open plan kitchen area with integrated appliances and bright, white units, and a spacious and comfortable lounge with adjoining bar/dining area which all receive an abundance of natural light from the multiple windows and bi-fold patio doors. Externally at this level, directly from the living space, there is an ample dining terrace with retractable awning for shade and which enjoys a very pleasant outlook over the communal pool area. Handily on this terrace to the side of the property, there is some built in external storage and sink area.

On the upper level there are three bedrooms, two double bedrooms both with fitted wardrobes and a third single bedroom with office space. There is a full family shower room and also a lovely upper terrace with easily maintained artificial grass installed and a beautiful ocean view, the perfect spot for a sunset cocktail. This lovely home has been further extended to incorporate a basement level where there is a sitting room with open plan kitchen, shower bathroom, and two bedrooms. This great self-contained apartment has independent access so would make the perfect space for visiting family or friends.
