Set on a plot of over 280m², and just 100 metres or so from the ocean, the layout of this fabulous air-conditioned villa has been designed to ensure maximum comfort and create a sense of connection with the natural surroundings. The property has its own private entry to a garage for two cars and which connects via private lift to the upper levels. At ground floor level can be found three nicely sized bedrooms with their corresponding bathrooms and each with patio doors leading out to ample terraces and garden areas, meaning that from every room the lovely outside space can be accessed and enjoyed. The main living area is found on the upper level, and this open concept living-dining-kitchen flows seamlessly through floor to ceiling glass doors to the incredible upper terrace of over 50m² with stunning private pool, chill out sofa area and dining space, all enjoying the same stunning ocean views in your own corner of paradise.

Over and above all this, at the lower level there is a separate studio style apartment with its own bathroom and kitchenette. This well considered space has plenty natural light and has its own external seating area, making it perfect for visiting guests or perhaps older teenage children.
